The proposed amendment shall be as follows and new words will be underlined and deleted words shall be lined through.

The said Amendment is expressed as follows:

Assessments and installments on them not paid within ten (10) days from due date shall bear interest at the maximum rate allowed by law, at the rate of 15% per annum, from due date until paid. In addition thereto, a fine of Twenty-five (\$25.00) Dollars for each month wherein payment is ten (10) days late shall be assessed at the rate of Twenty-five (\$25.00) for each month.

This is to certify that this amendment has been approved by a two-thirds (2/3) vote of the members or owners within the condominium association pursuant to title 718.110. Said vote having been taken on 30th day of April, 1995.

The Declaration of Condominium of Colonial House Condominium, is recorded in OR Book 2234, Page 881, Public Records of Brevard County, Florida and said Declaration of Condominium as so recorded will be deemed amended, upon the recording of this certification.
